WARNING AND ASSUMPTION OF RISKS AND WAIVER AND RELEASE OF CLAIMS

I recognize and acknowledge that there are certain risks of physical injury to participants in the Chilli Challenge, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in these activities against the Montour Area Recreation Commission, Talen Energy/Riverstone Holdings, Montour LLC, as well as their officials, agents, volunteers, sponsors and employees.

I understand that this race is inherently hazardous and the race course will present potentially dangerous obstacles and hazards including, but not limited to: motorized vehicles, bicycles, water, watercraft, irregular terrain, potentially dangerous weather conditions and unexpected acts of man or nature.

The Montour Area Recreation Commission insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for the race, programs/activities must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs. I do hereby fully release and forever discharge the Montour Area Recreation Commission, Talen Energy/Riverstone Holdings, Montour LLC, their officials, agents, volunteers, sponsors, and employees, from any and all claims for injuries, illnesses, damages, expenses, or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with the race, program or activities. In the event of personal injury, I consent to emergency medical care and transportation as medical professionals may deem appropriate.
